LTC Paulette Williams served this great country for 22 years. She served in numerous positions of increasing leadership and nursing-related management in both Army Nurse Corps and civilian careers. LTC Williams has been responsible for all facets of nursing, relating to planning, management, operational control coordination and evaluations. LTC Williams as a leader, maintained a high degree of involvement, displayed strong perseverance in everything she did. She taught, coached, trained, mentored and developed soldiers in order to accomplish missions successfully.

LTC joined the Armed Forces in 1985. She served in various positions of increasing responsibilities and scope such as Head Nurse/Officer in Charge of the Intermediate Care Ward & Neuro Psych Section, and Drug Demand Reduction Program Controller. of the 815th Station Hospital Unit, Bronx NY, and the 344th Combat Support Hospital. As a Major, during her deployment to Iraq 2005-2006, with the 344th CSH, she was Officer in Charge of the Neuro Psych section. She supervised Junior Officers and section Non Commissioned Officers, served a population of 8,400 Iraqi detainees, and coalition Forces in support of Operation Iraqi Freedom.
